### 4. Treasurer's Report

- Operating Account: \$48,113.27
- On November 25th, a 9-month CD at 3.84% was opened for reserve monies.
- Seven owners are outstanding.
- Plans for capital expenditure were discussed.
- The 2024 Profit and Loss Review was approved by Kelly, seconded by Denise.

### 5. 2025 Budget Review

• The 2025 Budget Vote by the Board was approved.

# 6. Old Business & Year in Review

- New park and the Little Library were established without using HoA funds.
- The fountain contract was renegotiated, and multiple repairs were made to address long-standing issues.
- A new entrance sign was installed, and the Village of Lemont funded new electric pull for lights and Christmas decorations, saving \$10k in fees.
- Landscaping contracts were evaluated, and additional areas of land are being maintained as part of the new contract.
- Thousands of dollars in unpaid HOA fees were recovered.
- All free-standing structures were validated as approved by previous boards.
- Renewed relationship with the Lemont PD.
- Tony Camardo was introduced and complimented the board on handling past concerns.
- Pond concerns were addressed, reminding everyone that fishing is allowed from dawn until dusk.

# 7. Block Party

- Another successful block party took place in August.
- Sponsorship was obtained from local businesses that are GoC homeowners.
- Interest in volunteers for next year's block party committee was discussed. Brooke will send out an email/survey to gauge interest.
- Continuing to look into a more user-friendly interface for the GoC website.

# 8. New Business

- Review of proposed Fine Schedule was approved by Denise, seconded by Kelly.
- The Board is working with KSN to combine all Declarations, Bylaws, and Amendments into one document. Every home will receive a paper and emailed copy of the consolidated CC&R's.
